

Request for Bids COSA Specification, Invitation to Bid:

- A. Under Deadline and Delivery Location, page 1: The project bid date has been changed. Sealed RFB submittals must be received no later than September 12, 2017, 1:30 PM, Local Time.
- B. Under General, page 1: Delete all mention of Estimated Length of Project. General Contractor shall list calendar days as required on Specifications Worksheet, page 21.

Request for Bids COSA Specification, Instructions to Venders:

- A. For all questions related to taxes, refer to Section 1.37, Taxes & Permits, page 8.
- B. Under Bid Sheet, Liquidated Damages, page 24: Delete all mention of Estimated Completion Time is 208 Calendar Days. General Contractor shall calculate and enter the estimated completion of the project in calendar days on the Specifications Worksheet, page 21.

Millwork and Interior Wood Doors, Refer to Specification 0623-2:

Note for Clarity: Keyed tumbler built-in locks as listed under Hardware, 2E shall be installed in (3) drawers located in Rooms 103, 106, 109, 112 & 115 for a total lock quantity of (15), refer to detail H/A-8 of drawings. Note that the Bedroom Lockers as shown on J/A-8 of drawings, the combination locks required to secure these lockers shall be furnished by the Owner.

Stainless Steel Equipment, Refer to Specifications 1140:

Under Materials and Equipment, item 4, It will be the Contractor's option to either use type 302 or 304 stainless steel material.

Substitutions as listed under Samples & Shop Drawings, Refer to Specification Section 0125:
