

**THE CITY OF SAN ANGELO, TEXAS
MINUTE RECORD OF A REGULAR MEETING OF
THE PUBLIC ART COMMISSION**

Following notice and publication, the Public Art Commission convened in a regular meeting at 3:30 p.m., **September 24, 2024**, in the Station 618 Conference Room, 618 S. Chadbourne, San Angelo, Texas.

I. OPEN SESSION (3:30 P.M.)

A. Call to Order

With a quorum of the Public Art Commission Members present, Mr. Dalglish called the meeting to order at 3:30 p.m. on Tuesday, September 24, 2024 at the Station 618 Conference Room, 618 S. Chadbourne, San Angelo, Texas 76903.

B. Public Comment

Mr. White spoke to the Commission and public about Resolution 2024-055 that outlines the reasonable rules for public comment at open meetings. He gave instructions on the matter and stated this will be in effect at all open meetings moving forward.

II. CONSENT AGENDA

- 1. Consider approving the April 30, 2024 minutes.** Mr. Stevenson motioned to approve the minutes. The motion was seconded by Ms. Bunker. The motion carried with (5) ayes to (0) nay, with no public comment.

III. REGULAR AGENDA: PUBLIC HEARING AND COMMENT

- 2. Discuss and consider an art mural at the skate park at Mountainview Park and recommend any related matters.** Mr. White showed pictures of a proposed mural at Mountainview Park as well as the park location. Mr. White discussed the artist for the proposed mural and presented examples of the artist's work to the Board. Mr. Dalglish and Mr. Stevenson asked questions about the material the current temporary mural is painted on. Mr. Kevin Little explained the condition of the temporary mural and recommended something more permanent. Ms. Bunker recommended the art be more content, and less name, focused. Ms. Stribling recommended the mural only be displayed during events. Mayor Brenda Gunter recommended the art be reflective of the location and community. It was determined that more thought will be put into this and be brought back to the Board at a later date for consideration of a more permanent work of art. In the meantime, the proposed temporary banner could be placed at approved events.

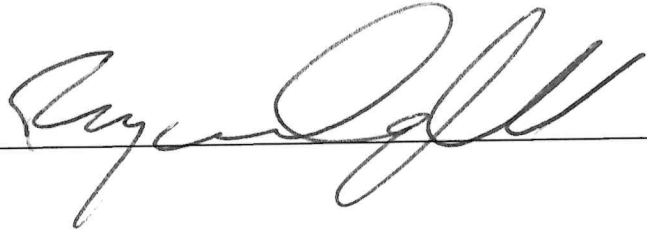
- 3. Discuss and consider recommending the adoption of new guidelines for the process and consideration of gifted or loaned art on public property.** Mr. White reviewed the need for updated guidelines. Mr. White discussed each section of the recommended guidelines with the Board and reminded the Board that the Public Art Commission has no source of funding and all art is donated or loaned. Mr. White asked the Board to review the guidelines. They will be discussed further at the next scheduled meeting. He also discussed the process for the final approval of the guidelines.

Ms. Mertz asked questions regarding details of the application for consideration of art placement as well as public access for this form and other documents for transparency with the public. Ms. Brooks inquired about the responsibility for the maintenance of art that is loaned or donated. Ms. Ramos asked questions about the process for reviewing applications for considering art and placement. Barbara Rallo had many questions about the process of approving art, placement of approved art and recommendations of being more interactive with the public.

- 4. Consider future agenda items.** The next meeting date and time will be determined at a later date.

IV. ADJOURNMENT

Ms. Stribling motioned for the meeting to be adjourned at 4:38pm. This motion was seconded by Mr. Stevenson. The motion carried with (5) ayes to (0) nay, with no public comment.
